COMPETITION TERMS

Policy Wording:

Altamont AUS Prize Indemnity wording (v21.10)

Conditions precedent:

1. There will be a maximum of one (1) participant only, selected at random by the Insured from the pool of eligible customers who have entered the Insured's promotional competition.
2. The process by which the participant is selected must be genuinely random, with no attempt made to select, or influence selection of, a participant who appears more likely to be physically able than any other. The participant must not be given prior notice of the specific details of what the competition entails in order to practice the specific task required to win. The participant is not allowed to wear specialised football boots with studs/tags/sprigs/cleats attached to or moulded into the soles.
3. There will be a maximum of one (1) attempt only.
4. The following participants are excluded and not eligible to take part in the competition:
5. Any current or former professional, semi-professional, or collegiate player of any form of Rugby League (including Nines), Rugby Union (including Sevens/Tens), Football, Soccer, AFL, NFL, Gaelic Football, or other football format;
6. Anyone that has ever received, or been entitled to receive, more than A\$10,000 in payment or reward (including match fees, sponsorship fees, cash, goods or services) for playing any form of Rugby League (including Nines), Rugby Union (including Sevens/Tens), Football, Soccer, AFL, NFL, Gaelic Football, or other football format;
7. Anyone that has ever been a member of, or played on, any State/Territory/Provincial or International team for any form of Rugby League (including Nines), Rugby Union (including Sevens/Tens), Football, Soccer, AFL, NFL, Gaelic Football, or other football format;
8. The participant selected at random to participate must be the same person who attempts the kick, a participant cannot nominate another person to take the kick on their behalf.
9. There are to be no practice kicks, warm up kicks or second chances/'do-overs', and there is to be no allowance of time for practice kicks or warm up kicks between the time the participant is selected and when they take their attempt.
10. Standard adult competition size rugby league ball and NRL approved field, field markings, and goal posts must be used.
11. The ball must be kicked off the approved kicking tee, placed at the exact location on the playing field at which the 40 metre line intersects with the broken line that runs parallel with the touch line 10 metres in from touch. Refer to the attached "Rugby League Pitch Map (40m kick).jpg" for a visual description of the acceptable tee locations.
12. The ball must travel directly from the participant's foot/shoe and pass between the two (2) goal post uprights and over the

crossbar in order to be deemed a successful attempt. The ball must not rebound off any object other than the goal posts and must not bounce on the ground before passing between the two (2) goal post uprights and over the crossbar.

13. The attempt(s) must be observed and adjudicated by two (2) NRL or NSWRL accredited match referees and video recorded in entirety, cost to be borne by the Insured.
14. In the event of a claim, an unedited, time & date stamped video recording must be provided to Underwriters as evidence of a successful attempt (in accordance with the conditions stated above. If the video recording does not verify a successful attempt in accordance with the above conditions the Insured Prize cannot be claimed.
15. Photograph of winner: The name and photograph of the winner may be used for promotional purposes by the Promoter, unless the winner notifies the Promoter at the time of accepting the prize that he or she does not consent to such use. Winner will be photographed with the dealer representative and relevant suppliers which will become the property of the said dealer and suppliers for promotional purposes.
